**Hazard Statements**

Flammable liquid and vapor.

8.2. Exposure controls

8.2.1. Engineering controls

NOTE: When used with a chemical dispensing system as directed, special ventilation is not required. Use general dilution ventilation and/or local exhaust ventilation to control airborne exposures to below relevant Exposure Limits and/or control dust/fume/gas/mist/vapors/spray. 8.2.2. Personal protective equipment (PPE)

Eye/face protection
